FACLC strives to provide access to justice for low-income families and children who, due to financial constraints and complex family transitions, would have no other means for representation in the courts. The overwhelming complexity of the legal system is compounded when financial barriers are present. Hit hardest during family transitions are low-income families - especially children. During such times, financial pressures can become unbearable and the home environment begins to or more precipitously unravel, causing legal needs to skyrocket. Continued on Schedule O.
